The interested Parties shall quote the rates in the financial bid format (BOQ) only. Any discrepancy in this regard will cause the rejection of bid. The Financial format (BOQ) shall contain the following:-

1. The rates should be quoted for per piece/Bundle. The rates for each item should be independent of other items.
3. The Tender offer form (BOQ) – Basic price, GST for each item shall be entered by the tenderer in the prescribed column of the tender sheet.
4. The bid shall contain only the price list. Any discrepancy in this regard will cause the rejection of bid.

GENERAL TERMS AND CONDITIONS FOR THE TENDERERS
(Instructions to Bidders)

1. Offer/Tenders must be filled through online mode only. The tenders filled in offline mode and through envelop will not be accepted and are subject to rejection. The rates in prescribed format 1 & 2 should be filled clearly and rate of GST should be quoted separately. The prices shall be on **FOR** basis anywhere in Himachal Pradesh.
2. Samples must be submitted and delivered in person or through their authorized representative in hpmc Head Office situated at 3rd floor Nigam Vihar, Shimla-2. Sample should bear a sealed label, marked with the offering Party's name and address. All instructions regarding the Samples specified in the notice should be complied with, all sample except those against accepted tenders must be removed by the suppliers within 15 days of the finalization of tenders, failing which the samples will become the property of hpmc. Similarly, the successful party who has put on rate contract shall remove their samples deposited against the rate contract after 90 days and before 120 days of the expiry of the contract where after the same shall become the property of the corporation and will be disposed off under the orders of the hpmc management, In such manner as may decide without giving any notice to the manufacturer/supplier/distributor.
3. Earnest money of Rs.1,00,000 (Rupees One Lakh each only) (refundable) & Tender Document Fee of Rs 1180/- (**non-refundable**) in the shape of Bank Draft/ NEFT/ RTGS be deposited in favour of Managing Director HPMC Ltd. Nigam Vihar, Shimla -2 and should be deposited through post or in person on or before the bid opening date i.e. on or before 11.00 A.M. till 08th July, 2022 and the scanned copy of both EMD & Tender Fee deposited in shape of Draft/ NEFT/ RTGS in technical bid cover without which tender will be considered invalid.
4. The offer must be accompanied by Goods & Services Tax (GST) clearance certificates showing the clearance of taxes up to 31st March of the preceding year.
5. The purchase Committee reserves the right of rejection /approval of all or any of the offer(s) without assigning any reasons thereto and reserves the right to negotiate with any of the tenderers where deemed necessary and to award parallel rate contract to any or all of the participating tenderers.
6. No offer will be considered unless all the documents are properly signed.
7. The manufacturer/supplier/distributor applying/bidding for the supply of carton if interested may also apply/bid for the supply of trays and separators and similarly trays/separator manufacturer/supplier/distributor may also bid for the supply of carton in case they fulfil all other terms and conditions/criteria fixed for the supply in order to supply complete packing material for packing of apple to the farmers/growers of the state in one platform.
8. The rates should be quoted FOR destination anywhere in Himachal Pradesh.
9. The Pre- dispatch inspection will be done by a team appointed by the Managing Director Horticultural Produce Marketing & Processing Corporation Ltd. Nigam Vihar Shimla -2. Four sets of samples on random basis shall be drawn by the inspecting team out of the lot of not more than

25,000 boxes at a time offered for dispatch in the presence of suppliers from their premises as per IS specifications for testing. One set will be utilized by the team for pre dispatch testing at manufacture's lab or some reputed lab, second for testing in H.P, Delhi or at the supplier and the forth one by the hpmc/procurement agency for reference and record. There will be no re-testing or re-inspection if the first sample fails. The dispatch instructions will be issued by the Corporation to such manufacturer/supplier/distributors who qualify in pre-dispatch test report from the inspection team. The charges of testing shall be borne by the Parties concerned.

10. Inspection of the cartons will be done by the representative/ authorised person of HPMC Ltd. and tests will be conducted at Horticulture Department Laboratory at Navbahar or Indian Institute of Packaging Delhi/ Bureau of Indian Standards Central Laboratory, Ghaziabad, Uttar Pradesh or other registered/certified Lab. Final payment shall be subject to the material passing such test satisfactorily.
11. The offering parties will furnish detail regarding the total production capacity of their unit total quantity being offered to HPMC for supply during the season, monthly supply schedule, details of machinery and testing facilities available with them or above detail of the Manufacturer with whom the supplier/distributor will be making supply tie-up.
12. The GST and other applicable taxes etc. be indicated separately otherwise rates will be deemed to be inclusive of such levies/taxes and no future increase in duty /taxes will be allowed
13. The Management would be at liberty to negotiate with any or all of the approved tenderers who could supply the carton at the shortest possible notice as per design, terms and conditions & requirement of hpmc for its own consumption as well as for supply to the fruit growers of the State on reasonable rates.
14. The interested parties may quote their offer for entire items as well as exclusively for any one of the item.
15. The last date of receipt of offer is 08th July, 2022 up to 11.00 A.M. The bid will be opened on the same day before the authorised representatives of interested parties at 2.00 P.M.

18. Other Specifications:-

(I) Flap and bend Test:- The flaps of the inner and outer piece of the box shall be capable of being folded through 180 Degree inside and then back through 180 degree angle along with the line

of creasing without showing any sign of cracking splitting. The flaps on bottom and top will be together and no space is to be left in between.

(II) Hygienic requirement:- To comply with the hygienic requirement, materials on or incorporated in the finished box shall :-

- d) Be substance prohibited any relevant regulatory authority or
- e) Contaminate the packed contents to a level likely to adversely affect its odour or colour.
- f) The adhesive used for pasting of the various plies of the board shall be of high quality free from silicate and water resistance of neutral PH reaction. No acidic or alkaline material be used.

(iii) Slots and Holes:- For handling, there should be a slot of 7 cm long and 2 cm wide in the centre of shorter sides of the cartons on each side.

(iv) Stitching Wire:

- (a) Stitching wire shall be flat corrosion resistant and not less than 2.4 mm wide and 0.5mm thick.
- (b) The crown of each stitch shall be not less than 10 mm long
- (c) The centre to centre spacing of stitches shall not exceed 65 mm.
- (d) There will be 2 joints each on top and bottom telescopic cartons, of course on alternative corners in top and bottom portions.
- (e) Staple wire will be fixed on the outer side of the cartons, outer parts of the cartons shall have joints inside. However, joints should be very smooth and may not harm fruit inside the box.

Marking and Identification:

- (a) Batch or lot No. should be given both on top and bottom piece of the cartons. This has to be the same on both the pieces.
- (b) Manufacturers name and trade mark should also be embossed both on top and bottom piece of the carton.

19. Printing:

Both side of the cartons a rectangular space measuring 31.5 cm in length and 10 cm in breadth with 0.5mm thickness of the boundary line with red & Black or other two colours should embossed for the convenience of the growers to put their stencils and trade name of the orchard. Carton to be supplied should bear the marking “for sale through HPMC only”.

20. Delivery:

- (a) Each party is required to supply as per schedule immediately on the receipt of the supply order.
- (b) The entire supplies of the cartons, trays, separator and other allied material will be completed within 10 days from the receipt of supply order. The supply order of the parties, who fail to supply prescribed quantity of carton, trays, separator and other allied material by due date, will be treated as cancelled and shortfall would be made good from other supplier at the cost and risk of the defaulters.

- (c) The supply should be made in bundles containing 10 outer and 10 Inner per bundle invariably and trays of 100 count bundle.
- (d) The supplier should reach at destination within 7 days from the date of inspection of the material.
- (e) Each supply should accompany the copy of supply order placed on the party.

21. Price Fall:

The price charged for the cartons supplied under this order by the supplier shall in no event exceed the lowest price at which the supplier sells the cartons or offers to sell carton of identical description to any persons/organization or any department of the Central Government or any department of State Government (except the hpmc under condition No.) or any statutory undertaking of the Central or State Government as the case may be during the period till all supply orders placed during the period of the supplies is completed.

If at any time ,during the said period the supplier reduces the sale price, sells or offers to sell such cartons/trays separator and other allied material to any person/or any organization or any Department of central Government or State Government or any Statutory undertaking of the Central or state Government, as the case may be, at a price lower than the price agreed under this supply order, he shall forthwith notify such reductions or sale or offer of sale to the hpmc and the price payable under the supply order, for the cartons, trays, separator and other allied material supplied after the date of coming in to force of such reduction or sale, or offer of sale shall stand correspondingly reduced and the payment will be made on such reduced prices.

A. Configuration:

The paper pulp trays shall be of any such configuration which may meet all the desired performance/specification mentioned hereunder:-

i) The Trays should be manufactured on Automatic plant.

ii) **Area of Deployment:** paper pulp trays will be filled with apples at orchards at a height of 4500 ft to 8500 ft and brought down to Road heads in small motor vans. The weight on each tray may vary from 04 to a maximum of 6 kg for 20/10kg carton. These paper pulp trays will be transported in Refrigerated trucks/Reefer containers or in Ordinary trucks. These paper pulp trays may be further kept inside Controlled Atmosphere Store / cold Store.

iii) **Handling:** At orchards/ CA Store the handling will be manual.

iv) **Temperature Exposure:** Paper pulp trays will be subjected to a minimum temperature of 1 deg C to a max of 38 Deg C. During pre cooling, the air flow rate will be approx. 20500 cfm, temperature will be brought down from 25 deg C to 5 deg C. Further the apple pulp trays filled with apples will be transported in refrigerated /Reefer trucks at 5 to 8 deg c and stored in CA store.

v) **Humidity Exposure:** To a maximum of 95%RH.

vi) **Dead weight load:** During transportation paper pulp trays will be kept one above other in 02 to 05 tiers. The bottom most paper pulp trays will have to with stand a dead weight equivalent to $W = 8 \times$ (dead weight of paper pulp trays + 04kg/06 kg. for 10kgcarton/20kgcarton respectively) Sufficient Factor of safety should be taken while calculating W assuming both dead weight and lateral forces during transportation.

vii) Performance:

Paper pulp trays should perform satisfactorily in above conditions and the different parameters given below should not go below the minimum specified value after subjecting trays to cold chain.

B. Other specification:

i. **Fresh Produce Safety Requirement-** To comply with the fresh produce safety requirement, no materials on or incorporated in the finished box shall:-

- a) Be substance prohibited by any relevant regulatory authority or
- b) Contaminate the packed contents to a level likely to adversely affect its odour or flavour.
- c) The chemicals used for paper processing should be of high quality food grade, certificate should be submitted in this regard

22. Earnest Money

In case the party fails to supply cartons as per terms and conditions specified above, the earnest money lying with the Corporation shall be forfeited. Besides this, the party may be black listed/debarred for further dealing.

All disputes shall be settled within the jurisdiction of the Courts of H.P. at Shimla.
